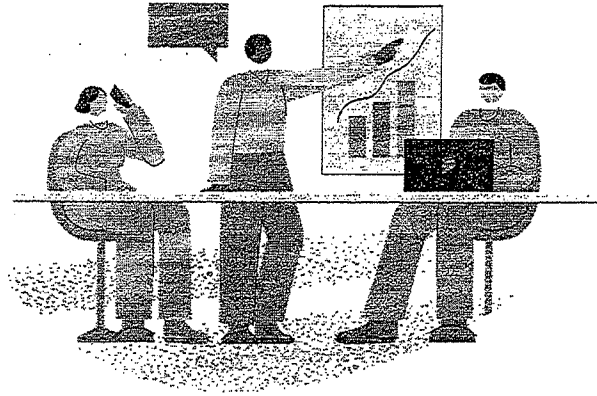


# MEETING MINUTES CITY COUNCIL REGULAR MEETING

## **SWEARING IN OF NEW COUNCIL MEMBER**

Newly elected Councilmember Theron Harris has won the former seat of Douglas Williams, Ward 2, Post 1. Judge Dubberly conducted the swearing in with Mrs. E. Harris, Wife of Theron Harris, acting as witness. Theron Harris continued the rest of the meeting in his new seat as Councilman.

## **MEETING CALLED TO ORDER**

The Mayor called the Regular Council meeting to order 5:18pm. Councilwoman Verdie Williams gave the prayer for the night. The meeting attendees recited the Pledge of Allegiance in unison. The Mayor began the meeting by informing the citizens about current updates on the limb/debris cleanup. Mayor Nail advises that no stumps will be picked up at this time. October 18<sup>th</sup> will be the last sweep for the City of Reidsville. Zeigler has crews out marking the large stumps. On the next sweep, stumps that are graded, will be collected.

## **NEW BUSINESS**

The PD has 2 vehicles that the City intends to sale with Council approval. The Mayor advises that the 2012 Crown Victoria (estimated value \$4,341) and 2014 Dodge Charger (estimated value \$6,412) will go for sale after a mechanical inspection as is. City Attorney Duann Davis is looking into the parameters for the sale. Verdie Williams offers a motion to sale the 2 vehicles.

Holly Dyer intends to keep her seat by virtue that an attorney in good standing has to remain on the board and be a resident of the City of Reidsville.

**Language Access Plan**-Council members were given handouts, informing them on the City's Language Access plan. The City has a staff member employed who can interpret Spanish for citizens. The Council voted to adopt the Language Access Plan. This LAP suffices requirements of the CDBG grant.
